I refer to your request, dated and received on 25th November, 2021 which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request sought:

Under the Freedom of Information Act 2014, I wish to seek records of the following: Meeting minutes, meeting agendas and documents circulated for discussion at the meetings of the Irish Language Policy Implementation Committee from 1.1.2018 to present.

I wish to inform you that I have decided to part-grant your request on the 21st December 2021.

The purpose of this letter is to explain that decision.

1. Findings, particulars and reasons for decision

Upon receipt, your request was forwarded to the relevant sections of An Garda Síochaná where searches where conducted in respect of same.

The Irish Language Policy Implementation Committee was established in 2018 chaired by Executive Director Human Resources & People Development in conjunction with An

Coimisinéir Teanga. It was established to increase the Irish language usage across An Garda Síochaná and in particular to insure that there were proficient Irish speakers within the force.

In 2021 the Irish Language Strategic Working Group was formed replacing the Irish Language Policy Implementation Committee. The first meeting of the new Committee took place in June 2021. The table below is a breakdown of the records provided.

The attached records are redacted in accordance with the FOI Act. As stated above, Part 1(n) of Schedule 1 states that An Garda Síochána is listed as a partially included agency. HR records refer to personal records of staff working within An Garda Síochána. They also relate to statistical information in respect of the organisation, e.g sick leave, discipline, retirements, etc. Financial records relate to the financial expenditure of the organisation and procurement records relate to the contracting of services and the tendering process associated with same.

In addition I can advise that following a detailed search for records carried out in the relevant Sections of An Garda Síochaná all records found are herewith attached. As no further records have been identified I am refusing the release of any additional records in accordance with Section 15(1)(a) of the Freedom of Information Act 2014 which states:

Refusal on administrative grounds to grant FOI requests:
