Re: Freedom of Information Request FOI-000453-2020 Request Refused

Dear

I refer to your request, dated and received on 10th December, 2020 which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request sought:

I wish to obtain the following records under the Freedom of Information Act. I want to obtain a list of all computer software, IT systems and IT hardware purchased and acquired by An Garda Siochana during 2019 and 2020. I wish to obtain the cost of the items purchased, the name of the supplier and their ultimate use.

I wish to inform you that I have decided to refuse your request on 11th January 2021.

The purpose of this letter is to explain that decision.

1. Findings, particulars and reasons for decision

This office has been advised that the retrieval of the records sought in your request would cause a significant disruption to the work of the IT Department due to the nature and volume of the records. The time required to retrieve, extract and examine all invoices in order to provide items, suppliers and ultimate use would cause a substantial and unreasonable interference and would significantly disrupt the workload of the Department. I am therefore refusing to provide this information to you in accordance with Section 15 (1)(c).

Refusal on administrative grounds to grant FOI requests:

Section 15(1)(c) of the FOI Act 2014 states;

- 15. (1) A head to whom an FOI request is made may refuse to grant the request where—
 - (c) in the opinion of the head, granting the request would, by reason of the number or nature of the records concerned or the nature of the information concerned, require the retrieval and examination of such number of records or an examination of such kind of the records concerned as to cause a substantial and unreasonable interference with or disruption of work (including disruption of work in a particular functional area) of the FOI body concerned,

However, the IT Department have supplied the table below which details the amount spent in 2019 and 2020. These amounts are recorded on the Financial Management System but as there is no unique code for all individual IT equipment purchased, to supply a further breakdown would require a manual trawl through a huge volume of invoices.
