#### Dear

I refer to your request, dated the 6<sup>th</sup> December, 2018 and received on the 7<sup>th</sup> December, 2018 which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

#### Your request sought:

- records containing details of all expenses, allowances and other costs paid in respect of the Garda band during 2017; to include the purpose of the payments and the number of recipients

I wish to inform you that I have decided to grant your request on the 12th December, 2018.

The purpose of this letter is to explain that decision.

### 1. Findings, particulars and reasons for decision

Details of your request were provided to the Finance Directorate within An Garda Síochána who conducted a search of their records. I am aware that you were contacted by my office and it was agreed that you would accept the total number of staff attached to the Garda Band rather the number of recipients of payments as sought in your original request.
