## Re: Freedom of Information Request FOI-000496-2018 Request Granted

*Dear*

I refer to your request, dated and received on 13<sup>th</sup> December, 2018 which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request sought:

**Original Request:**

*The number of Garda Civilian Staff attached to each Garda Station in Dublin Region as of 1 January 2018 and 10 December 2018 in tabular form.*

**Clarified Request:**

*Hi. You can give me the figures for 30 November 2018 and also give the figures as of 10 December 2017.*

I wish to inform you that I have decided to grant your request on 24<sup>th</sup> December, 2018.

The purpose of this letter is to explain my decision

### 1. Findings, particulars and reasons for decision

Upon receipt, details of your request were forwarded to Human Resource Management Section within An Garda Síochána who conducted a search and a number of records have been identified. These records are outlined at Appendix A

Over 2,500 full-time and part-time Civilian Staff work in An Garda Síochána, over 200 of these civilian members of staff are attached to the DMR Region.


