# Re: Freedom of Information Request FOI-000108-2017 Request Refused

#### Dear Mr. Kick,

I refer to your request, dated and received on 13<sup>th</sup> March, 2017 which you have made under the Freedom of Information Act (FOI) 2014 for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

#### Your request sought:

This is a request under the Freedom of Information Act 2014 for records about any assistance the US is giving to Ireland for protection of Trump International Golf Links at Doonbeg, as well as any other properties owned by Trump. This may be in the form of financial assistance, manpower, advisement, etc.

I wish to inform you that I have decided to refuse your request on the 28th March, 2017.

The purpose of this letter is to explain my decision.

#### 1. Findings, particulars and reasons for decisions.

The Finance section, which has responsibility to matters relating to costings, advised us that there are no records relating to your request for records "records about any assistance the US is giving to Ireland for protection of Trump International Golf Links at Doonbeg, as well as any other properties owned by Trump. This may be in the form of financial assistance, manpower, advisement, etc." Therefore I am refusing your request on the basis that the records that you have sought do not exist. Consequently it is not possible to extract the information you seek from financial records held by An Garda Síochána. Section 15(1) (a) of the FOI Act is applicable in this situation.

#### Section 15 - Refusal on administrative grounds to grant FOI requests

- 15. (1) A head to whom an FOI request is made may refuse to grant the request where—
  - (a) the record concerned does not exist or cannot be found after all reasonable steps to ascertain its whereabouts have been taken,

#### 2. Right of Appeal
