Dear Ms. Bracken,

I refer to your request, dated and received on 18th April 2017, which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request sought:

I am seeking records on of the annual policing costs at Dublin Airport from 2010.

I wish to inform you that I have decided to refuse your request on the 4th May 2017.

The purpose of this letter is to explain my decision.

1. Findings, particulars and reasons for decisions.

Details of your request were forwarded to the Finance Directorate within An Garda Síochána to ascertain if records could be identified to determine the costs associated with policing Dublin Airport from 2010.

Finance Directorate have advised this office that following an extensive search, it has been determined that financial records do not exist specifically for Dublin Airport. The Financial Management System can only provide expenditure reports for the DMR North Division which

includes Dublin Airport. This is the lowest level of expenditure reported that can be provided and it is not possible to sub-divide the DMR North Division further by location. Therefore, I must refuse your request pursuant to section 15(1)(a) of the FOI Act which states:

Refusal on administrative grounds to grant FOI request

- 15. (1) A head to whom an FOI request is made may refuse to grant the request where—
 - (a) the record concerned does not exist or cannot be found after all reasonable steps to ascertain its whereabouts have been taken,

2. Right of appeal
