I refer to your request, dated 1st January, 2024 and received on 2nd January, 2024 which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request sought:

Under the FOI Act 2014, I am seeking the following:

- the amount levied in fines for non-wearing of masks for each garda district for the calendar year 2021, 2022.
- the amount collected in fines for non-wearing of masks for each garda district for the calendar year 2021, 2022.
- the amount of fines written off for non-wearing of masks for each garda district for the calendar year 2021, 2022.

I wish to inform you that I have decided to <u>part-grant</u> your request on the 29th January, 2024. The purpose of this letter is to explain my decision.

1. Findings, particulars and reasons for decision

Upon receipt, your request was forwarded to the relevant section within An Garda Síochána who have provided records to this Office in response to your request.

I am refusing your request for records relating to 2021 and do so in accordance with Section 15(1)(i)(i) which states;

- 15. (1) A head to whom an FOI request is made may refuse to grant the request where -
 - (i) the request relates to records already released, either to the same or a previous requester where
 - (i) the records are available to the requestor concerned

Records in respect of levies for non-wearing of masks for 2021 where released to you previously on foot of your FOI request FOI-000100-2022 and are also available on the Garda website www.garda.ie

I can advise that 8 fines were issued for the non-wearing of a mask in 2022. The fine amount is €80, which gives a total amount levied in fines as €640. The table below provides a breakdown of the Districts where the fines were issued.

Furthermore I can advise 3 fines were paid in 2022. The fine amount is $\in 80$, which gives a total amount paid in fines of $\in 240$. The table below details the records.
