I refer to your request, dated and received on 17th August, 2023 which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request sought:

To the foi section of an gardai

I am requesting the following under the freedom of information act

How many bank accounts are currently open by an gardai as an organisation with bank of ireland?

How long have gardai used bank of ireland accounts.

Is the carba account ???

I wish to inform you that I have decided to grant your request on 24th August, 2023.

The purpose of this letter is to explain my decision.

1. Findings, particulars and reasons for decision

Upon receipt, details of your request were forwarded to Finance section of An Garda Síochána who conducted a search for records containing the information you requested.

This office has been advised that An Garda Síochána currently have 54 Bank of Ireland accounts open and have used Bank of Ireland accounts since 1925.

2. Right of Appeal

The review will involve a complete reconsideration of the matter by a more senior member of An Garda Síochána and the decision will be communicated to you within 3 weeks. The making of a late appeal may be permitted in appropriate circumstances.
