I refer to your request, dated 20th September, 2023 and received on 21st September, 2023 which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request sought:

I would like to make a request under the Freedom of Information Act 2014 concerning the following:

- 1. Documents detailing the cost associated with sending members of An Garda Síochana to France to assist local authorities during the 2016 UEFA European Football Championship.
- 2. Documents outlining the cost/projected cost associated with sending AGS members to France for the 2023 tourist season and Rugby World Cup.

I wish to inform you that I have decided to <u>part-grant</u> your request on 31st October, 2020. The purpose of this letter is to explain that decision.

1. Findings, particulars and reasons for decision

On receipt of your request, searches where conducted in the relevant sections within An Garda Síochána and some records were retrieved.

In Part 1 of your request, you sought the cost associated with sending members of An Garda Síochána to France to assist local authorities during the 2016 UEFA European Football Championship. I have been advised that the cost to An Garda Síochána amounted to €7,129 in Travel & Subsistence payments Additional cost were covered by the French organizing authorities.

In Part 2 of your request you sought records for the cost associated with sending AGS members to France for the tourist season and Rugby World Cup.

I can advise you that the cost to date for sending An Garda Síochána members to France for the tourist season is €4,247. Please note that this figure is for flights and associated costs and is subject to change.

There are no records available at present in respect of the part of your request that seeks the associated costs of the deployment for members of An Garda Síochána to the Rugby World Cup. In this regard, I am refusing this part of your request in accordance with Section 15(1)(a) of the Freedom of Information Act 2014 which states:

Refusal on administrative grounds to grant FOI requests

15(1)(a) the record concerned does not exist or cannot be found after all reasonable steps to ascertain its whereabouts have been taken

2. Right of Appeal

senior member of An Garda Síochána and the decision will be communicated to you within 3 weeks. The making of a late appeal may be permitted in appropriate circumstances.
