I refer to your request, received at this Office on 3rd October, 2023, which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána. I further refer to the clarification of your request received at this office on 9th October, 2023.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

I wish to inform you that I have decided to <u>part-grant</u> your request on the 3rd November 2023. The purpose of this letter is to explain my decision.

1. Findings, particulars and reasons for decision

On receipt, your request was forwarded to the relevant Sections of An Garda Síochána who have advised in respect of the records sought.

In respect of part 1 of your request, the table below outlines the spend charged to the Firearms Stores cost centre in the period in question.

I am refusing part 2 of your request. Under Section 6(2) of the Freedom of Information Act 2014, An Garda Síochána is, subject to the provisions of Part 1 of Schedule 1 of the Act, a public body for the purposes of the FOI Act. Part 1(n) of Schedule 1 states that in respect of An Garda Síochána the FOI Act applies only to administrative records relating to human resources, finance, or procurement matters. Records in respect of matters other than finance, procurement, or human resources matters are outside the scope of the FOI Act as it relates to An Garda Síochána.

Part 2 of your request seeks records in respect of the operation of Garda equipment. Such records do not constitute finance, procurement, or human resource records. As such, these records are outside the scope of the FOI Act and no right of access to these records exists. Part 2 of your request is therefore refused in accordance with Part 1(n) of Schedule 1.

In respect of part 3 of your request, I can confirm that the procurement in question was conducted in accordance with OGP guidelines.

2. Right of Appeal
