I refer to your request, dated and received on 1st July, 2024 which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request sought:

I am

looking to see if there is any figures on the garda compensation scheme since April 2023.

- 1. would there be latest figures on numbers of compensation and amount
- 2. Would there be a breakdown on the reasons for compensation sought.
- 3. Would there be a gender breakdown on the people seeking compensation.

I wish to inform you that I have decided to grant your request on 15th July, 2024. The purpose of this letter is to explain that decision.

1. Findings, particulars and reasons for decision

Garda Compensation Section have advised as follows based on statistics available at 27th June 2024 in relation only to claims originally submitted to the Minister for Justice under the repealed 1941-1945 Acts:

• At 10 April 2023 - 767 claims were not authorised by the Minister for Justice to proceed to the High Court for assessment.

- 602 have been re-submitted to the Garda Commissioner, of these, 551 have been processed and submitted to PIRB (59 of these have been settled and payments made to injured members).
- 158 have yet to be re-submitted, remainder were withdrawn.

Compensation Section have also advised based on statistics available at 27th June 2024 in relation to **all other claims** submitted to the Garda Commissioner under the Garda Síochána (Compensation) Act 2022

• 125 claims received - 92 have been processed and submitted to PIRB (10 of these have been settled and payments made to injured members).

The costs associated with the 69 claims settled from 10th April 2023 to 30th June 2024 comprises

General Damages - €1,176,201.14 Special Damages - €162,994.07 Legal Costs - € 83,009.70
