Re: Freedom of Information Request FOI-000003-2018 Request Part-Grant

Dear

I refer to your request, dated 30th December 2017 and received on 3rd January 2018 which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "*insofar as it relates to administrative records relating to human resources, or finance or procurement matters*". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request sought:

I would like to request the number of assaults/attacks that occurred on gardai in (a) the Sligo/Leitrim Garda division and (b) the Roscommon/Longford Garda Division, in 2017, along with information on the nature of each injury sustained and the compensation payments paid to officers as a result.

I wish to inform you that I have decided to part-grant your request on the 12th January 2018

The purpose of this letter is to explain that decision.

1. Findings, particulars and reasons for decision

On receipt of your request, the Health and Safety Section of An Garda Síochána conducted searches to identify records relevant to your request.

An Garda Síochána is very mindful to the significant occupational demands placed on its members, the exposure to injuries and very stressful and traumatic situations. Critical support is provided by the Chief Medical Officer, the Employee Assistance Service, the Peer Support Network and counselling services.

The table below details the number of incidents of assault that were reported to the Health and Safety Section in 2017 for Sligo/Leitrim and Roscommon/Longford Divisions.

I wish to inform you that I am refusing the final part of your request seeking “*the compensation payments paid to officers*”. Records relating to compensation claims for both malicious and accidental injuries are held by the National Treasury Management Agency (NTMA).

As a result, I am refusing this part of your request due to the fact that the records you are requesting are not held by An Garda Síochána. Section 15(1)(a) of the FOI Act is applied.

Refusal on administrative grounds to grant FOI requests

15 (1) A head to whom an FOI request is made may refuse to grant the request where
(a) The record concerned does not exist or cannot be found after all reasonable steps to ascertain its whereabouts have been taken
