## Re: Freedom of Information Request FOI-000004-2018 Request Granted

*Dear*

I refer to your request, dated and received on 3<sup>rd</sup> January 2018 which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request sought:

*The number of Gardaí by rank that left the Garda Band either through retirement or decided to leave the band in the year 2017; The number of vacancies by rank in the Garda Band as of 31 December 2017*

I wish to inform you that I have decided to grant your request on the 29<sup>th</sup> January 2018.

The purpose of this letter is to explain that decision.

### 1. Findings, particulars and reasons for decision

On receipt of your email, your request was forwarded to the Human Resource Management Section of An Garda Síochána where a search was conducted in respect of same.

We have been advised that there was one departure from the Garda Band in 2017 due to retirement of a Sergeant. There are currently four Sergeant vacancies within the Garda Band.

## 2. Right of Appeal


