#### Dear

I refer to your request, dated and received on the 9<sup>th</sup> November, 2017 which you have made under the Freedom of Information Act 2014 for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the Freedom of Information Act 2014 states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, finance or procurement matters".
