Dear

I refer to your request, dated and received on the 15th November, 2017, which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána. I refer further to email correspondence with my Office dated 22nd November, 2017 in which you clarified your request as set out below.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your initial request sought:

Annual statistics on the number of Garda vehicles that have been damaged while in use by on-duty Gardaí in the Republic of Ireland since 2003.

Your clarified request sought:

Annual statistics on the number of Garda vehicles that have been damaged while in use by on-duty Gardaí in the Republic of Ireland since 2008.

I wish to inform you that I have decided to refuse your request on the 4th December, 2017.

The purpose of this letter is to explain my decision.

1. Findings, particulars and reasons for decision

A search for records containing the information you have requested was conducted by the Fleet Management Section of An Garda Síochána.

The sections of the Act which can apply to deny access to records are known as its exemption provisions.

Section 6(2)(a) of the FOI Act provides that an entity specified in Schedule 1, Part 1 of the Act shall, subject to the provisions of that Part, be a public body for the purposes of the FOI Act. Schedule 1, Part 1 contains details of bodies that are partially included for the purposes of the FOI Act and also details of the certain specified records that are excluded. If the records sought come within the description of the exclusions of Part 1, then the FOI Act does not apply and no right of access exists.

Part 1(n) of Schedule 1 of the FOI Act provides that An Garda Síochána is not a public body for the purposes of the FOI Act other than in relation to administrative records relating to human resources, or finance or procurement matters.

The term "administrative records" is understood to mean records relating to the processes of running and managing a business or organisation.

I am therefore refusing your request as it is falls outside the scope of the FOI Act insofar as the records pertaining to the 'Annual statistics on the number of Garda vehicles that have been damaged while in use by on-duty Gardaí in the Republic of Ireland since 2008' do not meet the criteria of administrative records as defined in the Act.

However, in order to assist you, I wish to advise you that the information you have requested is already in the public domain. This information can be accessed in the Accounts of the Public Services (Appropriation Accounts) on the website of the Office of the Comptroller and Auditor General at the following URL:

The information you have requested is available under the heading entitled 'Statement of Losses (Garda Vehicles, etc.)' in Vote 20 Garda Síochána Appropriation Accounts to year ending 2016. This information relates to the number of accidents involving Garda vehicles.

2. Right of Appeal

The making of a late appeal may be permitted in appropriate circumstances.
