Dear

I refer to your request, dated and received on 21st July, 2023 which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request sought:

I would like to make a FOI request under the Freedom of Information Act 2014. Under section 7 of this act, I would like access to the records held by An Garda Síochána. The information I am seeking relates the road traffic enforcement fines revenue relating to the R830 Kill Lane, R827 Deansgrange Rd and R827 Clonkeen Rd Dublin.

In excel or pdf format, I am seeking the monthly monetary amount of all Fixed Charge Notices issued by An Garda Síochána on this road from 1 January 2019 to 30 June 2023, broken down by offence group and road (if possible).

I wish to inform you that I have decided to grant your request on the 8th August, 2023. The purpose of this letter is to explain my decision.

1. Findings, particulars and reasons for decision

Upon receipt your request was forwarded to the relevant Section of An Garda Síochána who have provided records to this office in response to your request. The tables below detail the breakdown of revenue and the number of offences issued for Kill Lane, Deansgrange Road, and Clonkeen Road from the 1st January 2019 to the 30th June 2023. Please note that figures are based on incidents which occurred from 01/01/2019 to 30/06/2023, inclusive. All information contained in this report is based upon operational data from the FCPS system as was available on 25/07/2023 and is liable to change.
