I refer to the Freedom of Information Act 2014 and your submissions to An Garda Síochána dated 3rd February 2016 and received on 4th February 2016.

Part 1(n) of Schedule 1 of the Freedom of Information Act 2014 states that An Garda Síochána is listed as a partially included agency “*insofar as it relates to administrative records relating to human resources, or finance or procurement matters*”.
