## Re: Freedom of Information Request FOI-000096-2016

### Out of Scope

Dear

I refer to your request, dated and received on the 2<sup>nd</sup> March 2016 which you have made under the Freedom of Information Act (FOI) 2014 for records held by An Garda Síochána.

Part 1 (n) of Schedule 1 of the Freedom of Information Act 2014 states that An Garda Síochána is listed as a partially included agency "*insofar as it relates to administrative records relating to human resources, or finance or procurement matters*". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request is shown below:

- 1) *The current amount of vehicles in the Garda fleet and the breakdown by year of registration.*
- 2) *The vehicles that are between 0 - 50,000km, 50,001km - 100,000km, 100,001 - 150,000, 150,001km - 200, 000km, 200,000km - 250,000km, 250,001 and above.*
- 3) *The amount of vehicles taken out of service for mechanical reasons between 2008 and 2015.*
- 4) *The service schedule for vehicles*

I wish to inform you that your request is outside the scope of the Act insofar as it pertains to An Garda Síochána and as a result I am refusing to provide the information you have sought in your request.
