Re: Freedom of Information Request FOI-000140-2016 Request Refusal – Out of Scope

Dear

I refer to the Freedom of Information Act 2014 and to your submissions to this body, dated and received on 13th April 2016.

Part 1(n) of Schedule 1 of the Freedom of Information Act 2014 states that An Garda Síochána is listed as a partially included agency "*insofar as it relates to administrative records relating to human resources, or finance or procurement matters*". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request sought:

The application is for all records in relation to the number of cyclists who have received on the spot fines since their introduction in August 2015, how many cyclists have paid the fines and has there been any people prosecuted for failing to pay such fines.

I wish to inform you that your request is outside the scope of the Freedom of Information Act 2014 insofar as it pertains to An Garda Síochána as the records sought are not "*administrative records relating to human resources, or finance or procurement matters*".

However, I advise that this information may be made available to you outside of Freedom of Information by submitting a media request to the Garda Press Office at Garda Headquarters, Phoenix Park, Dublin 8, D08 HN3X or emailing pressoffice@garda.ie.

Right of Appeal
