Dear

I refer to the Freedom of Information Act 2014 (FOI Act) and your submission to the Department of Justice and Equality which was transferred to An Garda Síochána and received on the 20th April 2016.

Part 1(n) of Schedule 1 of the FOI Act 2014 states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request is shown below:

"The information I seek pertains to the fraudulent registration of vehicles in the state of which I was a victim. Could you let me have all information involved i.e the number of vehicles envolved that you office may or maybe not aware off and all information surrounding all facts of the circumstances envolved."


I wish to inform you that your request is outside the scope of the FOI Act insofar as it pertains to An Garda Síochána. The purpose of this letter is to explain my decision.

1. Findings, particulars and reasons for decisions to deny access

In considering your request I have reviewed the FOI Act as it pertains to An Garda Síochána. As stated above An Garda Siochána is a partially included agency which means only certain types of records can be considered for release.

Your request does not seek administrative records relating to human resources, finance or procurement and is therefore outside the scope of the FOI Act for An Garda Síochána. On that basis I am unable to provide the records under the FOI Act.

2. Right of appeal
