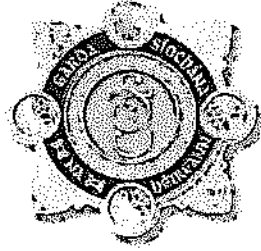

Re: Freedom of Information Request FOI-000155-2016

Dear

I refer to your request, dated and received on 21/04/2016 which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána.

Your request sought:

1. A list of Garda Stations, which do not have access to the Pulse System, as mentioned in the Garda Inspectorate report (Nov 2015).
2. A list of Garda Stations with no 999 electronic call recording systems.
3. Requests from An Garda Síochána for new computers and mobile technology.
4. Complaints made by Garda over lack of or poor quality technology.
5. Any communications between the Garda Commissioner and Minister for Justice relating to the technological requirements of the Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "*insofar as it relates to administrative records relating to human resources, or finance or procurement matters*". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

I wish to inform you that your request is outside the scope of the FOI Act insofar as it pertains to An Garda Síochána.

Right of Appeal

You should submit your request for an Internal Review within 4 weeks from the date of this notification. The review will involve a complete reconsideration of the matter by a more senior member of An Garda Síochána and the decision will be communicated to you within 3 weeks. The making of a late appeal may be permitted in appropriate circumstances.
