## Re: Freedom of Information Request FOI-000159-2016 Request Out of Scope

Dear

I refer to your request dated 24<sup>th</sup> April 2016 and received on the 25<sup>th</sup> April 2016 which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána.

Your request sought:

*\*Details, where possible, of how many cases of Necrophilia/Interference with Corpse and Theft of a Corpse/ Human Body were recorded between 1996 to 2016 (March).*

*\*Details, where possible, of how many of these offences recorded as sexual offences.*

I am to inform you that the terms of FOI Act states that An Garda Síochána is listed as a partially included agency “insofar as it relates to administrative records relating to human resources, or finance or procurement matters”. Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

I wish to inform you that your request is outside the scope of the FOI Act insofar as it pertains to An Garda Síochána.

However, I wish to advise you that the Central Statistics Office provide crime and justice statistics.
