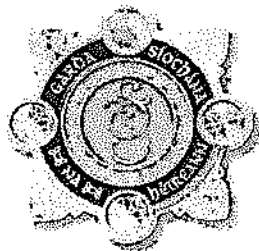

I refer to your request, dated and received on 26/04/2016 which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána.

Your request sought:

- Correspondence between An Garda Síochána and representatives of the GoSafe Consortium in relation to traffic monitoring and enforcement during between 1 June 2015 and 31 December 2015.

I am to inform you that the terms of FOI Act states that An Garda Síochána is listed as a partially included agency "*insofar as it relates to administrative records relating to human resources, or finance or procurement matters*". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

I wish to inform you that your request is outside the scope of the FOI Act insofar as it pertains to An Garda Síochána.

The making of a late appeal may be permitted in appropriate circumstances.
