I refer to your request, dated and received on 04/05/2016 which you have made under the Freedom of Information Act (FOI Act) 2014 for records held by An Garda Síochána.

Your request sought:

The numbers of the Sex Offenders Register.

A county by county breakdown of the numbers currently on the Sex Offenders Register (e.g. Carlow - 3, Cavan - 4, Clare 2, Cork 14)

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency “*insofar as it relates to administrative records relating to human resources, or finance or procurement matters*”. Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

I wish to inform you that as the records you have sought do not relate to either human resources, finance or procurement your request is outside the scope of the FOI Act insofar as it pertains to An Garda Síochána.

Right of Appeal
