## Re: Freedom of Information Request FOI-000175-2016

Dear

I refer to your request, dated 24/04/2016 to the National Transport Authority transferred to An Garda Síochána on 03/05/2016 which you have made under the Freedom of Information Act (FOI) 2014 for records held by An Garda Síochána.

Your request sought:

- The number of taxi drivers that have had their SPSV licences revoked.
- This figures to be broken down by month.
- This number not to include taxi drivers who have decided not to renew their SPSV licences.
- The reasons that drivers have had their licences revoked, with figures given for the reasons why drivers most frequently have their licences revoked.
- This to cover a period from 1 January 2015 up to 31 March 2016.

Part 1(n) of Schedule 1 of the Freedom of Information Act 2014 states that An Garda Síochána is listed as a partially included agency "*insofar as it relates to administrative records relating to human resources, or finance or procurement matters*". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

I wish to inform you that your request is outside the scope of the Freedom of Information Act 2014 insofar as it pertains to An Garda Síochána, as the records sought by you do not relate to human resources, finance or procurement.

### **Right of appeal**
