## Re: Freedom of Information Request FOI-000235-2016 Refused

Dear

I refer to your request, dated 21<sup>st</sup> June 2016 and received on 23<sup>rd</sup> June 2016 which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency “*insofar as it relates to administrative records relating to human resources, or finance or procurement matters*”. Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request is shown below:

*I am writing to you to make a request under the Freedom of information Act 2014, for the details of all individual holders of a Garda Collection Permit, as well as of those who have been in possession of a permit within the last 24 month period, as administered by each Garda Division and as required for the legal collection of cash from the public in any public place or places or by home to home visits, pursuant to the terms of the House to House Collections Act 1962, as updated by the Charities Act 2009.*

*This information is being sought in written format if possible, and the request includes the name of the applicant; the name of the body (if applying as the nominee of a body); as well as the date(s) and agreed hours for which collection is permitted with respect to each.*

I wish to inform you that I have decided to refuse your request on the 6<sup>th</sup> July 2016.

The purpose of this letter is to explain my decision.

#### **1. Findings, particulars and reasons for decision.**

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "*insofar as it relates to administrative records relating to human resources, or finance or procurement matters*". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered. Your request is in relation to an operational policing matter which is a core function of An Garda Síochána. Records relating to the core functions of An Garda Síochána are excluded from the ambit of the FOI Act.

I am therefore refusing your request as it falls outside the scope of the FOI Act insofar as it pertains to An Garda Síochána.

#### **Right of Appeal**

The making of a late appeal may be permitted in appropriate circumstances.
