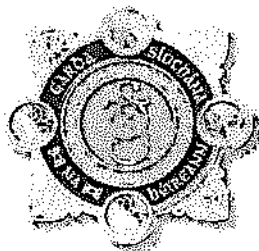

## Re: Freedom of Information Request FOI-000240-2016

Dear

I refer to your request, dated 29/6/2016 and received on 30/06/2016 which you have made under the Freedom of Information Act (FOI) 2014 for records held by An Garda Síochána.

Your request sought:

- I wish to request access to the following records.  
All correspondence concerning the number of number plates stolen from vehicles in each of the past five years.  
I am seeking a county by county breakdown of the number of thefts.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

I wish to inform you that I have decided to refuse your request on the 1<sup>st</sup> July, 2016.

The purpose of this letter is to explain my decision.

## 1. Findings, particulars and reasons for decisions.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "*insofar as it relates to administrative records relating to human resources, or finance or procurement matters*". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered. Your request is in relation to an operational policing matter which is outside the scope of the FOI Act insofar as it pertains to An Garda Síochána.

## 2. Right of appeal

In the event that you are not happy with this decision you may seek an Internal Review of the matter by writing to the address below and quoting reference number **F01-000215-2016**.

You should submit your request for an Internal Review within 4 weeks from the date of this notification. The review will involve a complete reconsideration of the matter by a more senior member of An Garda Síochána and the decision will be communicated to you within 3 weeks. The making of a late appeal may be permitted in appropriate circumstances.
