Dear

I refer to your request, dated 09/07/16 and received on 11/07/2016 which you have made under the Freedom of Information Act (FOI) 2014 for records held by An Garda Síochána.

Your request sought:

Please can you tell me how many people have been 1) arrested and 2) charged and 3) convicted in relation to incidents at Quinn Group, and/or Aventas Group and/or Quinn Industrial Holdings in Ballyconnell, County Cavan in the last three years, including details.

I wish to inform you that I have decided to refuse your request on the 12th July 2016.

The purpose of this letter is to explain my decision.

1. Findings, particulars and reasons for decision.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered. Your request is in relation to an operational policing matter which is a core function of An Garda Síochána. Records relating to the core functions of An Garda Síochána are excluded from the ambit of the FOI Act.

I am therefore refusing your request as it falls outside the scope of the FOI Act insofar as it pertains to An Garda Síochána.

2. Right of Appeal

The making of a late appeal may be permitted in appropriate circumstances.
