## Re: Freedom of Information Request FOI-000295-2016 Refusal

#### Dear.

I refer to your request, dated the 3<sup>rd</sup> August 2016 and received on the 4<sup>th</sup> August 2016 which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

#### Your request sought:

- 1. How many sex criminals are there on the sex offenders list at the moment?
- 2. How many sex criminals were there on the sex offenders list on 03/08/15?
- 3. How many sex criminals were there on the sex offenders list on 03/08/14?
- 4. How many sex criminals were there on the sex offenders list on 03/08/13?
- 5. How many sex criminals were there on the sex offenders list on 03/08/12?
- 6. How many sex criminals were there on the sex offenders list on 03/08/11?
- 7. How many sex criminals were there on the sex offenders list on 03/08/10?
- 8. How many sex criminals were there on the sex offenders list on 03/08/09?

- 9. How many sex criminals were there on the sex offenders list on 03/08/08?
- 10. How many sex criminals were there on the sex offenders list on 03/08/07?
- 11. How many sex criminals were there on the sex offenders list on 03/08/06?
- 12. How many sex criminals were there on the sex offenders list on 03/08/05?
- 13. How many sex criminals were there on the sex offenders list on 03/08/04?
- 14. How many sex criminals were there on the sex offenders list on 03/08/03?
- 15. How many sex criminals were there on the sex offenders list on 03/08/02?
- 16. How many times so far in 2016 have Gardai had to inform authorities in another country that a sex offender is leaving Ireland to go to their country?

I have decided to refuse your request on the 8<sup>th</sup> of August 2016.

The purpose of this letter is to explain that decision.

### 1. Findings, particulars and reasons for decision to deny access

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered. Your request is in relation to an operational policing matter which is a core function of An Garda Síochána. Records relating to the core functions of An Garda Síochána are excluded from the ambit of the FOI Act.

I am therefore refusing your request as it is falls outside the scope of the FOI Act insofar as it pertains to An Garda Síochána.
