Re: Freedom of Information Request FOI-000370-2016 Refused

Dear

I refer to your request, dated and received on 10th October, 2016 which you have made under the Freedom of Information Act (FOI) 2014 for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency “*insofar as it relates to administrative records relating to human resources, or finance or procurement matters*”. Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request sought:

Copies of correspondence to/from An Garda Síochána in relation to the review of the reopening of six Garda stations as set out in the Programme for Partnership Government.

The correspondence can be limited to representations made by Ministers, TDs, Senators and County/City Councillors and responses given by An Garda Síochána between May 6, 2016 and October 10, 2016.

The records should include copies of letters, emails, faxes, transcripts or notes of phone calls, and copies of any documents enclosed with letters or attachments to emails.

I wish to inform you that I have decided to refuse your request on the 14th October, 2016.

The purpose of this letter is to explain my decision.

1. Findings, particulars and reasons for decision.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "*insofar as it relates to administrative records relating to human resources, or finance or procurement matters*". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered. Your request is in relation to an operational policing matter which does not come within the ambit of this partially included agency as set out in Part 1(n) of Schedule 1 of the FOI Act.

I am therefore refusing your request as it falls outside the scope of the FOI Act insofar as it pertains to An Garda Síochána.

2. Right of Appeal

You should submit your request for an Internal Review within 4 weeks from the date of this notification. The review will involve a complete reconsideration of the matter by a more senior member of An Garda Síochána and the decision will be communicated to you within 3 weeks. The making of a late appeal may be permitted in appropriate circumstances.
