Dear

I refer to your request, dated 20th October, 2016 and received on 21st October, 2016 which you have made under the Freedom of Information Act (FOI) 2014 for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "*insofar as it relates to administrative records relating to human resources, or finance or procurement matters*". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request sought:

I would like to know the number of times Gardai were called to incidents involving schools, colleges and universities over the last five years. What types of crimes were committed e.g. Burglary etc.?

I wish to inform you that I have decided to refuse your request on the 21st October, 2016.

The purpose of this letter is to explain my decision.

1. Findings, particulars and reasons for decision.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "*insofar as it relates to administrative records relating to*

human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered. Your request is in relation to an operational policing matter which does not come within the ambit of this partially included agency as set out in Part 1(n) of Schedule 1 of the FOI Act.

I am therefore refusing your request as it falls outside the scope of the FOI Act insofar as it pertains to An Garda Síochána.

However, information you seek may be available from Central Statistics Office who receive all crime related data from An Garda Síochána. They can be contacted at Skehard Road, Cork, T12 XOOE, Ireland or alternatively you can email them at crime@cso.ie with your request.

2. Right of Appeal
