Dear

I refer to your request, dated 24th November 2016 and received on the 25th November 2016 which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency *"insofar as it relates to administrative records relating to human resources, or finance or procurement matters"*. Therefore, only administrative records that relate to human resources, finance or procurement shall be considered

Your request sought:

1. Under the Freedom of Information Act I am requesting the email policy of the force and any computer security information made available to members

I wish to inform you that I have decided to refuse your request on the 19th December, 2016.

The purpose of this letter is to explain my decision.

1. Findings, particulars and reasons for decision.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency *"insofar as it relates to administrative records relating to*

human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request is seeking information pertaining to Garda Information Technology and Information Technology Security matters. These types of records are not considered an administrative record and do not come within the ambit of this partially included agency as set out in Part 1(n) of Schedule 1 of the FOI Act.

I am therefore refusing your request as it is outside the scope of the FOI Act insofar as it pertains to An Garda Síochána.

2. Right of Appeal
