Re: Freedom of Information Request FOI-000430-2016 Refused

Dear .

I refer to your request, dated and received on 28th November, 2016 which you have made under the Freedom of Information Act (FOI) 2014 for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency “*insofar as it relates to administrative records relating to human resources, or finance or procurement matters*”. Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request sought:

- i. Crisis intervention teams since 2006 to date.*
- ii. Community intervention teams since 2006 to date.*
- iii. Education and training courses organised by An Garda Síochána for the Gardai in relation to the Mental Health Act 2001.*
- iv. The Memphis Crisis Intervention Team model of policing.*
- v. Any follow-ups on The Report of Joint Working Group on Mental Health Services and the Police 2009 - I already have this report.*

I wish to inform you that I have decided to refuse your request on the 28th November, 2016.

The purpose of this letter is to explain my decision.

1. Findings, particulars and reasons for decision.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency *"insofar as it relates to administrative records relating to human resources, or finance or procurement matters"*. Therefore, only administrative records that relate to human resources, finance or procurement shall be considered. Your request is in relation to an operational policing matter which does not come within the ambit of this partially included agency as set out in Part 1(n) of Schedule 1 of the FOI Act.

I am therefore refusing your request as it falls outside the scope of the FOI Act insofar as it pertains to An Garda Síochána.

2. Right of Appeal

The review will involve a complete reconsideration of the matter by a more senior member of An Garda Síochána and the decision will be communicated to you within 3 weeks. The making of a late appeal may be permitted in appropriate circumstances.
