## Re: Freedom of Information Request FOI-000442-2016 Request Refused

*Dear*

I refer to your request, dated and received on the 1<sup>st</sup> December 2016 which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered

Your request sought:

- *Which garda stations in Cork City division do not have access to PULSE system?*
- *Which garda stations in Cork North division do not have access to PULSE system?*
- *Which garda stations in Cork West division do not have access to PULSE system?*

I wish to inform you that I have decided to refuse your request on the 5<sup>th</sup> December, 2016.

The purpose of this letter is to explain my decision.

## **1. Findings, particulars and reasons for decision.**

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "*insofar as it relates to administrative records relating to human resources, or finance or procurement matters*". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered. Your request is seeking information pertaining to operational Garda matters and is not considered an administrative record and does not come within the ambit of this partially included agency as set out in Part 1(n) of Schedule 1 of the FOI Act.

I am therefore refusing your request as it is outside the scope of the FOI Act insofar as it pertains to An Garda Síochána.

## **2. Right of Appeal**

The making of a late appeal may be permitted in appropriate circumstances.
