## Re: Freedom of Information Request FOI-000114-2024 Request Granted

#### Dear

I refer to your request, dated and received on 21st March, 2024 which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

#### Your request sought:

Could you provide me with the following information under the Freedom of Information Act 2014

1) The number of WTE Garda Civilian Staff by grade working in each Garda Station within DMR as of 1 March 2024 in tabular form

I wish to inform you that I have decided to grant your request on the 27th March 2024.

The purpose of this letter is to explain that decision.

### 1. Findings, particulars and reasons for decision

Upon receipt, your request was forwarded to the relevant section of An Garda Síochána to retrieve the information requested by you and a number of records have been identified.

Whole Time Equivalent (WTE) numbers are provided to indicate that garda staff work on a number of different work-sharing patterns of varying hours. The WTE number reflects the number of whole time staff required to work the number of hours provided by the staff actually employed. The table below provides the number of Garda Staff attached to Dublin Garda Stations as at the 01/03/2024.
