Dear

I refer to your request, dated and received on 5th October, 2023 which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request sought:

I request the following records; I am currently studying for a Post Graduate Certificate in Workplace Wellness in Trinity College. As part of this course I am required to examine wellbeing in An Garda Síochána. The data I am requesting will be used solely for this purpose and will be disposed of appropriately afterwards. I am seeking data for 2020-2023 inclusive relating to Garda Members (All ranks) and Garda Staff (Civilians) to identify the impact of our wellbeing strategy on our members health physical and psychological. I respectfully request the following data:

- 1. Figures relating to the number of days lost due to illness by a) Garda Members (all ranks) and b) Garda staff (civilians) for 2020, 2021, 2022 and 2023 to date, including specifics around critical illness, occupational injury/illness arising from duty and ordinary illness as recorded on SRI forms and SAMS.
- 2. Figures relating to the number of a) Garda members (all ranks) and b) Garda Staff (civilians) for 2020, 2021, 2022 and 2023 to date who took sickness absence due to Mental Health illness.

- 3. Figures relating to the number of days taken/lost of a) Garda members (all ranks) and b) Garda Staff (civilians) for 2020, 2021, 2022 and 2023 to date because of Mental Health Illness.
- 4. Figures relating to the number of a) Garda members (all ranks) and b) Garda Staff (civilians) for 2020, 2021, 2022 and 2023 to date that were referred for psychiatric/psychological assessment by the Garda Occupational health office.
- 5. Figures of a) Garda members (all ranks) and b) Garda Staff (civilians) for 2020, 2021, 2022 and 2023 to date who have died by suicide.
- 6. Figures relating to a) Garda members (all ranks) and b) Garda Staff (civilians) for 2020, 2021, 2022 and 2023 to date detailing their ranks if possible who resigned of their own volition or resigned in lieu of dismissal.
- 7. Figures relating to a) Garda members (all ranks) and b) Garda Staff (civilians) for projected retirements for the remainder of 2023 and 2024 including details of any early retirements.
- 8. Figures of a) Garda members (all ranks) and b) Garda Staff (civilians) on the date of processing this application for the following:
 - Presenteeism- members actively reporting for duty
 - Maternity leave
 - Paternity leave
 - Parental leave
 - Career break
 - Suspended
 - Sick leave including uncertified sick, certified sick, injury on duty.

I wish to inform you that I have decided to part grant your request on the 2nd November, 2023.

The purpose of this letter is to explain that decision.

1. Findings, particulars and reasons for decision

Upon receipt, your request was forwarded to the relevant section of An Garda Síochána to retrieve the information requested by you and a number of records have been identified.

In accordance with Section 15 (1)(d) of the FOI Act I am refusing to release the records requested in part 1 of your request for the year 2020, 2021 and 2022. These years were subject to a previous FOI requests (FOI-000278-2022 & FOI-000127-2023) and as it is the policy of An Garda Síochaná to publish all non-personal requests that result in release of records.
