Dear

I refer to your request, dated and received on **16th October, 2023** which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "*insofar as it relates to administrative records relating to human resources, or finance or procurement matters*". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request sought:

I wish to be furnished with the following;

- 1. The number of Garda Members having reached 60 years of age afforded an extension to service from 30 September 2021 to 30 September 2023.*
- 2. Breakdown by Gender of those afforded an extension to service.*
- 3. Breakdown by Rank of those afforded an extension to service.*

I wish to inform you that I have decided to grant your request on the 8th November, 2023.

The purpose of this letter is to explain that decision.

1. Findings, particulars and reasons for decision

Upon receipt, your request was forwarded to the relevant section of An Garda Síochána to retrieve the information requested by you and the following records have been identified.

The following table outlines the number of Garda Members, by Rank and gender having reached 60 years of age and approved for an extension to service from 30 September, 2021 to 30 September, 2023:

The making of a late appeal may be permitted in appropriate circumstances.
