## Re: Freedom of Information Request FOI-000372-2023 Request Granted

#### Dear

I refer to your request, dated and received on 2<sup>nd</sup> November, 2023 which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

### Your request sought:

I would like to obtain the following information under the Freedom of Information Act.

How many gardaí in Donegal Division have taken sick leave in the first six months of this year?

Can I have a breakdown of the length of time gardaí in Donegal Division have taken sick leave in the first six months of this year, for example, one week, one month etc?

What are the reasons cited for sick leave in the first six months of this year, for example, injury at work, stress, mental health difficulties?

I wish to inform you that I have decided to grant your request on the 22<sup>nd</sup> November 2023. The purpose of this letter is to explain that decision.

### 1. Findings, particulars and reasons for decision

Upon receipt, your request was forwarded to the relevant section of An Garda Síochána to retrieve the information requested by you. I have been advised that sickness absences are

recorded and reported under the following categories - Critical Illness, Occupational Injury/Illness Arising from Duty and Ordinary Illness.

The tables below provide the records you seek in relation to days lost to illness by Garda members in the Donegal Division in the first six months of 2022.
