# Re: Freedom of Information Request FOI-000445-2023 Request Part Grant

### Dear

I refer to your request, dated 28<sup>th</sup> December, 2023 and received on 29<sup>th</sup> December, 2023 which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

### Your request sought:

Under the Freedom of Information Act 2014, I would like to request the total number of attacks on gardai in (i) 2021, (II) 2022 and (iii) 2023, with a breakdown by garda division, and by the injuries that were suffered.

I wish to inform you that I have decided to part-grant your request on 15th January, 2024.

The purpose of this letter is to explain that decision.

## 1. Findings, particulars and reasons for decision

Upon receipt, your request was forwarded to the relevant sections within An Garda Síochána who have provided records to this Office in response to your request.

Section 15(1)(d) of the Freedom of Information Act allows for the refusal of a request where the information sought is already in the public domain. Section 15(1)(d) states that:

Refusal on administrative grounds to grant FOI requests

15. (1) A head to whom an FOI request is made may refuse to grant the request where – (d) the information is already in the public domain.

Part of your request seeks the total number of attacks on Gardaí in 2021 and 2022. This has been the subject of a previous FOI request. As it is the policy of An Garda Síochaná to publish all non-personal FOI requests that result in a release of records on our website <a href="www.garda.ie">www.garda.ie</a>.

As the records for years 2021 and 2022 in your request are already in the public domain, I am refusing these parts of your request in accordance with Section 15(1) (d). You can access these records by following the link attached below.

The making of a late appeal may be permitted in appropriate circumstances.
