Re: Freedom of Information Request FOI-000264-2023 Request Part-Grant

Dear

I refer to your request, dated and received on 27th July, 2023 which you have made under the Freedom of Information Act 2014 (FOI Act) for records held by An Garda Síochána.

Part 1(n) of Schedule 1 of the FOI Act states that An Garda Síochána is listed as a partially included agency "insofar as it relates to administrative records relating to human resources, or finance or procurement matters". Therefore, only administrative records that relate to human resources, finance or procurement shall be considered.

Your request sought:

I wish to know the total amount of new members of the Garda Siochána who have been assigned to the DMR West Division in 2022 and so far this year.

I also wish to know the total amount of new members of the Garda Síochána who have been assigned to Clondalkin Garda Station.

I also wish to know the total amount of members of the Garda Síochána in the DMR West Division who are currently suspended from duty, if any. I also wish to know if any members of the Garda Síochána based in Clondalkin Garda Station are suspended from duty.

I wish to inform you that I have decided to <u>part-grant</u> your request on 14th August, 2023. The purpose of this letter is to explain that decision.

1. Findings, particulars and reasons for decision

Upon receipt, your request was forwarded to the relevant sections of An Garda Síochaná where searches where conducted in respect of same. We have been advised that in 2022 there were 43 new members of An Garda Síochána assigned to DMR West with 12 being assigned to

Clondalkin. So far in 2023 there were 16 new members of An Garda Síochána assigned to DMR West with 5 being assigned to Clondalkin.

I am refusing to provide records in relation to the number of members suspended in the DMR West Division as I believe that as your request is specific to DMR West and individuals involved would become easily identifiable beyond their family and friends and it would be considered a breach of the confidentially upon which the information is being held by the Garda Organisation. The release of information with regard to such a small number of members may allow for a person to become more identifiable and possibly named in the public domain. Therefore I am refusing release same in accordance with 37 (1) of the FOI Act which states;

Section 37 - Personal Information

37 (1) Subject to this section, a head shall refuse to grant an FOI request if, in the opinion of the head, access to the record concerned would involve the disclosure of personal information (including personal information relating to a deceased individual).

Personal information is defined at Section 2 of the FOI Act and includes the following:

Section 2 – Interpretation

- 1. (1) In this Act—
 "personal information" means information about an identifiable individual that, either—
 - (a) would, in the ordinary course of events, be known only to the individual or members of the family, or friends, of the individual, or
 - (b) is held by an FOI body on the understanding that it would be treated by that body as confidential,

There is a Public Interest Test applicable to Section 37 of the FOI Act.

Public Interest Test

As per Section 37 of the FOI Act I have considered the public interest issues which arise in this case and have taken account of the following factors in favour of release:

- Ensuring openness and transparency of organisational functions to the greatest possible extent,
- The public interest in members of the public exercising their rights under the FOI Act,
- That there is more than just a transitory interest by the public in this information,
- The right to privacy is outweighed by the needs of the public.

In considering the public interest factors which favour withholding the records I have taken account of the following:

- Allowing a public body to hold personal information without undue access by members of the public,
- The public interest is not best served by releasing these records,
- That the Organisation can conduct its business in a confidential manner.
- That there is a reasonable and implied expectation by employees that sensitive personal information will remain confidential,

 That there is no overriding public interest that outweighs the individual's right to privacy.

A public interest test was carried out when considering the release of records. I decided that the public interest in preserving the personal information and the reasonable expectation that information can be maintained in a confidential manner by An Garda Síochána.

However, in order to assist you I can advise that currently there are 32 members suspended in the DMR Region.

2. Right of Appeal

In the event that you are not happy with this decision you may seek an Internal Review of the matter by writing to the address below and quoting reference number FOI-000264-2023.

You should submit your request for an Internal Review within 4 weeks from the date of this notification. The review will involve a complete reconsideration of the matter by a more senior member of An Garda Síochána and the decision will be communicated to you within 3 weeks. The making of a late appeal may be permitted in appropriate circumstances.
